He is also the Vice-Chairman of the European Corporate Reporting Lab@EFRAG Steering Group.

Arlene McCarthy OBE is Executive Director of AMC Strategy. She is Special Advisor to the Chairman of Bloomberg on Strategic affairs, and to Bloomberg Philanthropies specifically supporting the UN Special Envoy for Climate on Climate Finance and Environment programmes. Arlene is a Non-Executive Director for Bloomberg MTF (Multilateral Trading Facility).

Arlene was a member of the European Commission High-Level Expert Group on Sustainable Finance (Jan 2017 – Feb 2018). During 20 years as an MEP, she chaired the European Parliament's Internal Market Committee (2006-2009) and was Vice Chair of the Economic Committee and Monetary Affairs Committee

(2009-2014). She was named as one of the top 100 influential women in European finance in 2010, 2011 and 2012 and was awarded MEP of the year in 2014 for her work in financial services. She was also awarded an OBE in the Queen's 2015 New Year's Honours List for Parliamentary and Political Services.

Elisabeth Gambert is Director for CSR & International Affairs at Afep (Association Française des Entreprises Privées), representing the top 120 multinational companies operating in France. She is also Co-Chair of the Corporate Reporting Working Group of EuropeanIssuers, a pan-European organisation representing publicly quoted companies across Europe.

Within Afep, Elisabeth leads working groups with CSR managers of the largest French and international companies to reach common positions on legislative and regulatory proposals (French law on the duty of care, reporting and verification of non-financial information, sustainable finance...). She participates

in the work of the Global Compact France and multi-stakeholder initiatives (CSR Platform France) and had responsibility for the creation of a compendium of companies' best practices on due diligence (identification and management of human rights and environmental risks along supply chains).

Elisabeth holds a Master degree in Law from the University of Vienna, a Diploma of Advanced Studies (DEA) in European Law from the University of Rennes I and a European Master of Governance and Administration from the Humboldt University of Berlin and the University of Paris I Panthéon-Sorbonne. Prior to joining Afep, Elisabeth worked with FEDIOL (EU Federation of Seed Crushers and Oil Processors) in Brussels and a District Court in Vienna (Austria).

Flavia is Director at the Luxembourg Green Exchange, the key stock exchange for listing of green bonds. A member of EFRAG's EU reporting Lab and of the EIOPA Occupational Pension Stakeholder Group, Flavia has supported the work of the European Commission to devise a sustainable finance framework as member of the High-Level Expert Group on Sustainable Finance (HLEG). As part of the Technical Expert Group (TEG) she assisted the European Commission to define a European Standard for Green Bonds.

With 18 years of experience in sustainability, Flavia was previously Executive Director of Eurosif, the pan-European sustainable and responsible investment

(SRI) membership organisation whose mission is to promote sustainability through European financial markets.

As a sustainability consultant and qualified environmental auditor at EY and Deloitte, she assisted companies embed sustainability in their business models and go beyond the remits of social and environmental compliance. Focused on issues ranging from climate change and adaptation, to supply chain management and responsible investments, Flavia worked with several European banks and asset managers to help them streamline their Responsible Investment approach. A founding member of the UN Global Compact in Belgium, Flavia has developed much of her career working with companies to improve their transparency and accountability through material and forward-looking sustainability reporting.
