IFRS 17 Insurance Contracts Project Update

Objective

- 1 The objective of this session is to consider:
 - (a) An update on the progress in developing a draft endorsement advice for IFRS 17 *Insurance Contracts*; and
 - (b) The current project plan.

A. PROJECT UPDATE

2 The following is a summary of progress since the conference call of the EFRAG Board on 19 February 2018.

Meetings

EFRAG TEG meeting 7 – 8 March 2018

- 3 Topics discussed included:
 - (a) Proposed background papers on *Release of CSM* and *Transition*; and
 - (b) Papers submitted to the February 2018 meeting of the IFRS 17 Transition Resource Group.
- 4 There was no EFRAG IAWG meeting in March as EFRAG IAWG members did not present new issues for discussion. The EFRAG IAWG meeting in April will focus on the papers developed for the May 2018 meeting of the IFRS 17 Transition Resource Group

Activities

- 5 The tender for the economic study has now been let and the kick-off meeting with the consultants was held on 13 March. The draft report is due by 16 July. The final report is due by 3 September and will be followed by a presentation to the EFRAG Board.
- 6 The IFRS 17/Solvency II comparative study has been contracted and the draft technical comparison will be discussed with the consultant later in March.
- 7 Initial meetings with participants of the full case study have now been completed. Follow-up meetings will increase in regularity given that the year-end reporting season is almost completed.
- 8 Other meetings with outside parties included:
 - (a) Presentation of the simplified case study to Insurance Europe; and
 - (b) Meeting with Insurance and Pension Denmark.
- 9 For the user outreach, a draft structured questionnaire has been developed with the assistance of a couple of users. The internal review is expected to be completed this week and will be followed by pilot testing before the call for participants is released.
- 10 The background briefing papers for *Release of CSM* and *Transition* were approved by EFRAG TEG for issue after a final fatal flaw review by EFRAG IAWG. The background briefing paper on *Level of Aggregation* was issued on 23 February, following a fatal flaw review by EFRAG TEG and EFRAG IAWG.
